Animas Fire Protection District Board of Directors,

I have compiled the accompanying balance sheet of the Animas Fire Protection District as of April 30, 2011, and the related statement of revenues and expenses - actual for four months then ended compared to budget for twelve months December 31, 2011 ended and prior year, in accordance with Statements on Standards for Accounting and Review Services issued by the American Institute of Certified Public Accountants.

A compilation is limited to presenting in the form of financial statements information that is the representation of management. I have not audited or reviewed the accompanying financial statements and, accordingly, do not express an opinion or any other form of assurance on them. The accompanying annual budget of the Animas Fire Protection for the year ended December 31, 2011, has not been audited by me, and accordingly, I do not express an opinion on it.

My responsibility is to conduct the compilation in accordance with Statements on Standards for Accounting and Review Services issued by the American Institute of Certified Public Accountants. The objective of a compilation is to assist the Board of Directors in presenting financial information in the form of financial statements without undertaking to obtain or provide any assurance that there are no material modifications that should be made to the financial statements.

Management has elected to omit substantially all of the disclosures, statements of fund balances, and cash flows required by generally accepted accounting principles, and the summaries of significant assumptions and accounting policies required under established guidelines for presentation of perspective financial statements. If the omitted disclosures and summaries were included in the financial statements and budgeted information, they might influence the user's conclusions about the Animas Fire Protect District's financial position, results of operation, cash flows and budgeted information. Accordingly, these financial statements and budgeted information are not designed for those who are not informed about such matters.

Other comprehensive basis of accounting (OCBOA): A definite set of criteria, other than GAAP, having substantial support underlying the preparation of financial statements prepared pursuant to that basis.

The financial statements have been prepared using a basis of accounting that the reporting entity uses to comply with the requirements or financial reporting provisions of a governmental regulatory agency to whose jurisdiction the entity is subject C.R.S. 29-1-601.

I am not independent with respect to the Animas Fire Protection District.
